This is one of my favorite times of the year. It is a time to reflect on the many things that we are thankful for and a time to celebrate with family and friends. This time of the year, I reflect on the things that mean the most to me. As I think about all of those things this year, our students and staff are at the top of my list. I am also thankful for the community and the support that is given to our schools. Our school district has so much to be proud of.

State report cards were recently released. The district met expectations as a whole. John Hustis Elementary also met expectations. The Jr./Sr. High exceeded expectations on the state report card. These rankings reflect the hard work and dedication that our staff and students put forth each and every day. Our students are performing at or above state averages. There is always room for improvement and we will continue to work on ways to improve our scores and student outcomes. We will be implementing new writing curriculum at the middle school, we added teacher FTE's in order to better serve our students, we added new science options at the high school, we added Advanced Placement (AP) classes at the high school, allowing students the possibility to earn college credit, we have created a curricular rotation cycle to better review various areas of studies to ensure that we are providing the best for our stu-

We are able to use the funds from the grant to bring in new items and training for our teaching staff and our students. The grant has allowed us to focus more on the whole child and ensure that we are meeting academic and social-emotional needs of children. The Board of Education and the administrative team work diligently to ensure that our students have what they need to succeed.

Student events are once again in full swing. We have both boys' and girls' basketball at all levels underway. Take time some evening and stop in to cheer on our teams. Our wrestling season is also underway. Holiday concerts are coming up as well. John Hustis will be having their concert on December 14th at 6:30 in the high school gym. The Jr./Sr. high will have their band and choir concert on December 19th at 7 p.m. The drama presentation of "The Fat of the Land" will take place on December 9th at 7 p.m. and December 10th at 2 p.m.

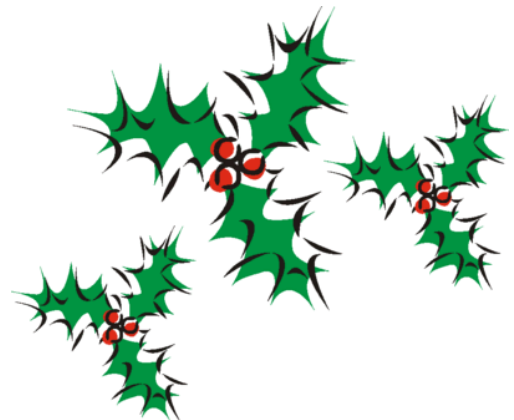

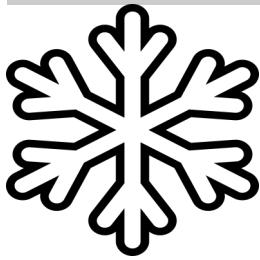

Greetings from Jr./Sr. High School Principal Mr. Clint Bushey



The first quarter of the school year has come and gone. It was awesome to see the excitement of students as they received their reports cards and hearing how proud they were of their accomplishments. I could not agree with them more. Great job students of Hustisford! On November 15th the student body

and the community were given the privilege of hearing Nationally renowned speaker, author, and filmmaker Kevin Hines. Kevin's story is a remarkable testament to the strength of the human spirit, his story of an unlikely survival, his strong will to live, and a reminder for us to love the life we have. Through his message of hope and courage students heard his struggle with mental health challenges. This topic can be and was very emotional for many students. If you notice changes in your child's behavior and persona, please talk to them and try to get them to share how they are feeling and what they are dealing with. Here are some suggestions to help with those difficult conversations.

National Association of School Psychologists recommendations:

Youth who feel suicidal are not likely to seek help directly; however, parents, school personnel, and peers can recognize the warning signs and take immediate action to keep the youth safe. When a youth gives signs that they may be considering suicide, the following actions should be taken:

- Remain calm.
- Ask the youth directly if he or she is thinking about suicide (e.g., "Are you thinking of suicide?").
- Focus on your concern for their well-being and avoid being accusatory.
- Listen.
- Reassure them that there is help and they will not feel like this forever.
- Do not judge.
- Provide constant supervision. Do not leave the youth alone.
- Remove means for self-harm.
- *Get help:* No one should ever agree to keep a youth's suicidal thoughts a secret and instead should tell an appropriate caregiving adult, such as a parent, teacher, or school counselor. Parents should seek help from school or community mental health resources as soon as possible.
- If needed have child text 741741 to speak to a trained individual that can help.
- Or call [1-800-273-8255](tel:1-800-273-8255) to speak to a trained professional that can help.
- If child is in imminent danger please call 911.
