BE IT FURTHER RESOLVED, that to evidence such indebtedness, the District President and District Clerk are hereby authorized, empowered and directed to make, execute, issue, sell and deliver to the Hustisford State Bank its tax and revenue anticipation promissory note on a taxable basis (the "Note") payable to the order of the Bank in the principal amount of \$300,000 in accordance with the terms and conditions of the attached documentation. The Note shall be dated as of the date of its issuance to the Bank identified above; shall bear interest at the rate set forth in the attached documentation from its dated date until paid; and shall mature no later than November 1, 2017.
