<u>Mr. Bushey Reported</u>: Mr. Bushey reported that the Academic Bowl team competed. Four students placed in our conference. Students participated in Dodge County Government Day. There will be 9<sup>th</sup> grade parent orientation meeting on April 24. Prom is April 27. Senior project presentations are on April 29. May 6<sup>th</sup> is parent orientation for incoming 6<sup>th</sup> grade students. May 6<sup>th</sup> is the District band concert and May 14<sup>th</sup> is the choir concert. May 16<sup>th</sup> is a parent night for juniors in regards to Senior Projects. May 15<sup>th</sup> is the Junior/Senior banquet. Two students participated in state forensics. The conference honors banquet was held honoring our valedictorian, Sydney Stigler and our salutatorian, Sophia Hamden.

<u>Ms. Bell Reported</u>: Ms. Bell reported that JHE is in the last round of EPIC interventions. Forward exams are complete at JHE. Summer school registration continues. Friday, April 27 is VIP Day, Science Fair, Art Fair, and Book Fair at JHE. There are many activities happening with students at JHE over the next month. Fifth grade graduation is May 28 at 6:30 pm.
