Tuesday, I have the tour with CD Smith at 10 am and with Kraus-Anderson at 12:30 pm. I have a tour with CG Schmidt on Thursday at 11 am. I am working to set up the tour with Kraemer.
- Summer school registration continues. We are working to see if it is possible to have all students other than the
  fitness center and tech ed at JHE for summer school to help out the maintenance staff with schedules for cleaning
  and maintenance.
- On Friday, May 6 we had a state-wide superintendent zoom meeting. These meetings are sponsored by CESA 5.

**Present**: Steve Weinheimer, Chair; Brian Thimm, Member; Fred Miller, Director of Technology; and Heather Cramer, Superintendent.

- Technology Updates—Mr. Miller provided an update on the technology issues that the district has been facing. The
  network is still not running at 100%. He is currently working on making registration forms interactive so that parents will
  not need to print all forms. He also indicated that there are device issues occurring regularly. We have had several
  failures and issues.
- Technology Summer Planning/Projects—This summer the servers will need to be updated to the newest version.
   Interactive boards will be installed in classrooms at both buildings. Each building will have three. The wireless update is still not in the district. We are hoping to have the materials shipped soon. This project has been delayed for a full year due to parts not being available. The firewall will also be updated this summer.
- Future Technology Planning—We need to start thinking about 2 factor authentication for the district. Mr. Miller also needs to start looking into Google as it is moving toward tiers and charging for features. This will affect us in the future. The 9<sup>th</sup> graders will be moving to Chromebooks; we will start to look at needs shortly after device return to see where we are at. Mrs. Cramer inquired about staff computers and if any updates were needed.
- 2022-2023 PK-12 Programming—The committee discussed the timing of a 3K program. The committee would like for
  this to be on discussion for May 16. The committee looked at the senior project book and the updates. The only
  updates were for dates. The committee would seek full approval on May 9. Mrs. Cramer indicated that they are
  working on three new hires for the May 9 or 16 board meeting.
- Future Facilities Planning—Mrs. Cramer handed out the information from each of the firms that submitted an RFQ. The committee took a quick look at the books. The full board will discuss at the May 9 board meeting and work to come up with a shortlist for interviews.
