D. Superintendent's Report

Points of Interest:

- We completed interviews for Ag and will need to schedule a meeting to seek approval. We also completed the Business
 Manager interviews, which is on for approval tonight. Also completed was HS Special Education aid which is also on
 the agenda. The only opening right now is Tech. Ed. I have reached out to a company that has a partnership in the
 Milwaukee area with schools and I am waiting to hear back from them in regards to training that they can provide to
 help in the event that position is not filled.
- I have my monthly library meeting tomorrow, July 16. I had a Rec Board meeting last week Wednesday.
- I have our next Neola update on July 29. There are two policies on tonight for approval due to Federal Implementation on August 1. This is something that we as a district are working through. Clint, Dena, and I are going through extensive online training for implementation. The staff will also all need to be trained during in-service. I was fortunate to get the training for free from a law firm. They are one of the only groups offering the training for free.
- The JHE staff is currently doing training to meet the ACT 20 requirements. I found training online that meets all requirements and it is free. Staff are getting compensation points for doing the training. The training is 31 hours long with a test at the end.
- I met with the principal from Bethany in regards to Title funding for 2024-2025.
- The end of the year Title reports are now open and I will be completing them.
- I am currently working on the 2024-2025 Title applications and documents.

- We had a Trailways Superintendent meeting on July 10. The meeting focused on Title IX implementation and Act 20 training as well as hiring and referendum discussions.
- I have completed the WASB Honor Roll nominations. We will get our certificates within the next month or so.

- Educator effectiveness is ready to be rolled over for next year. I will start that process shortly to have it ready to go for the start of the school year.
- New in the newsletter this quarter was an alumni spotlight piece. We are looking for alumni and their stories. We have had a couple of responses. We are excited for this new feature.

New Business:

- Maintenance Update—Mrs. Cramer provided a brief update on maintenance updates that had been completed during the summer months. The district is currently waiting for the company to do the flame test for insurance purposes on the stage curtain. We are working on getting the interior cross connection inspection done for our permit. This is a mandate that we need to do. Many areas at the HS are complete with cleaning. There was an issue with one of the HS water heaters, it is giving an ignitor fail. The trophy case is ready for demolition. The Special Education room at the HS has a leak, the maintenance crew is working on cleaning the wall and removing the panel on it. They will seal and repaint the wall. The committee discussed the underlying problem that is causing the leak. Mrs. Cramer will work to have this looked at further.
- HVAC –The AC at JHE is not working. The office AC was repaired. A piece was taken from a broken unit at the HS to fix the JHE unit in the office there. Bassett is working on scheduling the work for the AC repairs and install approved at the last board meeting.
- Athletic Facilities Update—Booster Club—The Booster Club presented information on moving forward with creating a master plan for softball field facility updates. They will be working with the Point of Beginning to move forward with the planning. This is a cost that will be completely funded by Booster Club.
- Future building planning—HSR Presentation/Discussion—HSR was present for the meeting to discuss
 future facility planning in the District and the direction that the District may go. The committee discussed
 the challenges with a potential November referendum and the timeline for that. The committee also
 discussed priorities for a referendum and what board members had identified as ideas. The committee
 also discussed community engagement and survey potential. The committee heard from HSR on ideas for
 more community engagement and how to gauge the community. The board will continue the discussion
 during Board Development during the regular July meeting.

New Business:

- Budget Update –Mrs. Holtz provided a budget update. We are currently at 88% in Fund 10, 95% in Fund 27, 94% in Fund 50 and 89% in Fund 80. There are several claims that still need to be processed as well as final expenditures and income. The special education transfer will also need to be completed. The accounts are looking good; we are awaiting the final pieces to come together to see where the year ends.
- Staffing Updates—Mrs. Cramer discussed updates in regards to vacancies and the interviews that will be happening.
- 24-25 Budget Planning—The Schultz Bus contract is in and will need to be renewed this year. They are looking for a 2.5% increase. This is going to be on the board agenda for approval in July. We continue to work on the budget. The initial DPI release for aid on July 1 indicated a 9.69% increase or \$141,042. However, these numbers are extremely preliminary and will likely change by the end of October.
- 2024-2025 Milk Bid—The district received a milk bid from Engelhardt Dairy. The proposal will be on the July meeting.
- Long-Term Disability Renewal—The Standard renewal is for 2025. The renewal is 0%. This will be on for approval in July.
- Discussion on Business Manager Position for the Interim—Mrs. Cramer indicated that she had discussed options with CESA 5. They will work with a new person to help with the transition. CESA 5 will help with the budget, September reporting, and the Annual Meeting to assist a new hire. Jessica will hopefully be able to train a new person until she is finished.
- Annual Meeting Update—Mrs. Cramer and Mrs. Holtz updated the committee on a webinar they viewed on the Annual Meeting and updates in regards to that.
