- **Senior Projects: Planning for 2017 – 2018—**The class of 2018 received their information on the senior project. Several students have handed in proposals. Students and parents both were given opportunities to receive the information.
- **Jr./Sr. High School Scheduling—**Scheduling with students is complete. The new schedule had very few glitches within it. The next step is for Jenny Nettesheim and Clint Bushey to get the schedule into Infinite Campus. This will be completed by July 1 so that all of the information will be included in the year roll over within the system.
- **Curricular Updates—**Dave Jasperson requested that a machine that is not useable at this point get updated in the shop. We will be looking at new books to purchase for Human Anatomy and Consumer Math as well as Probability and Statistics. We are working on a partnership with UW Oshkosh to create two classes that students will be able to take to receive college credit. The classes are through the math department.
