**Review of Compensation Models:** The committee continued to review compensation models. They took a look at specific criteria within the models first as a means for advancement on a plan. The committee discussed and reviewed a plan from Dodgeand. The group would like to have a discussion with Dr. Annette Thompson in regards to their model and how they are sustaining the model and how the staff is adjusting to the model. The group also looked at a plan from West Salem. The committee looked at different concepts within the plan and discussed the pros and cons of each of the concepts.

**Compensation Plan Structure:** The committee once again reviewed the dif-

ference in structure between a step and lane grid vs. a ladder structure. The committee looked at different district models to see the set-up and what that would mean for Hustisford. The team looked at a model from West Salem and indicated that they felt that it took too long to attain the steps on the scale and that while they liked the concept, it would be nice to reduce the number of years needed to accomplish the end of the scale.

**Criteria for Advancement – Items for Consideration/Discussion:** The committee continued to discuss the various ways that teachers could move within a compensation plan. The committee discussed providing a monetary value to obtaining a master's degree. The committee also discussed criteria used for advancement either in a point system or checklist system. The committee briefly discussed providing stipends for certain situations and staff for duties or criteria that is laid out.

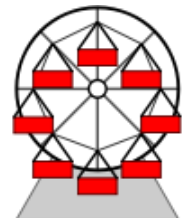
