A Message from the Superintendent...

I want to start out this month's newsletter with all of the great celebrations that we have had in the district. Congratulations to the girls' basketball team on their regional championship. It is a great accomplishment for the team, their hard work and dedication has paid off! We had three wrestlers, Ethan Wilder, Logan Nicholls, and Kody Schmidt, make it to the sectional wrestling meet this year as well. Although their season ended at sectionals, they worked hard all season to get to where they were. We had five individuals advance to state for their solo ensemble performances. The students that made it were Arial O'Neil, Allison Noll, Ariel Nelson, Sarah Schmidt, and Julia Bamke. Our forensics students have had solid performances this year. Two students advanced past our sub-district meet, both receiving perfect scores from at least one of their judges. The students are Maria Noll and Sophia Hamden. Julia Peplinski recently made her commitment to Crookston University in Minnesota to continue her basketball career. Halle Grulke committed to play volleyball and continue her career with Lake Superior State in Michigan. We wish both senior athletes the best of luck. The boys' basketball team will be opening up regional play this week, receiving a 3 seed for our regional. Our middle school basketball teams have all finished successful seasons as well. Our students are able to participate in tournaments and always make us proud. Great things are also happening at John Hustis Elementary. Students continue to work hard and be recognized for their positive

choices and great character traits that they display. Numerous students are recognized monthly for their accomplishments. The students at JHE have been doing community service projects as well, learning about the importance of giving back. I am so proud of all that our students accomplish in our schools and in the community. I am eager to look at the paper each week to see what great things our kids have done. Continued support from our community will help them to continue to achieve great things.

While we know we are doing great things each and every day, we face many challenges as well. We have been blessed for the past three years to have an operational referendum to help the district move initiatives forward in technology, expand educational opportunities, and maintain staffing levels. The operational referendum is currently set to expire at the end of this school year. The district will once again be asking voters to support an operational referendum to continue to build on the programs that we already have in place. The voters will face a guestion on the April election ballot that asks for support for the district to exceed the revenue limit specified in Section 121.91 of Wisconsin State Statutes by \$200,000 per year beginning in the 2018-2019 school year and ending in the 2020-2021 school year. How will this impact our taxpayers? The mill rate will decrease next year even with a successful referendum. If the voters within the district were to approve the question as stated, vot



ers throughout the district are predicted to see a



1.71% <u>decrease</u> in the mill rate from this year. The mill rate is predicted to go from \$9.53 this year to \$9.36 next year with a yes vote.

The biennial budget introduced this year for the State of Wisconsin supported public schools with an increase of per pupil funding. This increase helped us to decrease our mill rate this past year as well. The funding will be used to maintain and enhance current programs and staffing, expand educational opportunities, and purchase new curricular materials. What are some of the specifics that the district is looking to do with this additional funding? The district will bring back Agriculture Education to the Hustisford District. For the past several years, we have shared an Ag program with Dodgeland School District, we have the need to have our own Ag teacher and have a thriving Ag program taught right here in our District again. Our students and families have asked to bring this program back and the Board of Education and Administration support this and wish to bring the program in-house. This will provide for more opportunities for students wishing to take the AG classes, but also offer more science options for our high school students. The district is looking to hire a teacher with an Agriculture and Science background to enhance science options for students.

A Message from the Superintendent Continued....

This past year, we were able to expand math offerings for middle and high school students, providing more options for students and providing them opportunity to take classes that are motivating and challenging. This past year, the District added 2 Advanced Placement (AP) courses for high school students. These courses allow students to take a placement test at the end of the course and potentially receive credit toward their post-secondary education. The District is looking to add more AP offerings in different departments to our students, preparing them for the challenges that they will face in college level courses as well as providing them the opportunity to get credits prior to entering college. It helps put our students on the same playing field as surrounding districts. The District is working diligently to update the curriculum that students receive daily. Two years ago, the District was able to update the math curriculum K-12. The District also updated the writing curriculum at John Hustis Elementary. This year, the district updated several math offerings, updated with AP classes, updated some middle school offerings, updated the elementary science curriculum, and developed two new science electives for high school students. The district will have an updated reading curriculum for John Hustis and the middle school will be adopting the same writing curriculum being used at JHE. It is an exciting time for our students and teachers. Many other curricular materials are out of date. We have very old textbooks that are challenging for our students and teachers to use. The District is looking at the Social Studies Department next, working with the heads of the department to find a curriculum to bring K-12 on the same scope and sequence and provide students with a comprehensive curriculum that meets 21st Century learning objectives. These are a few of the many initiatives that we have in place here in the District. We are so excited to bring opportunities to our students both academically and through extra-curricular offerings. The District needs the support of our constituents to help fulfill our educational goals. Our students do amazing things each day and the District is working to provide the tools that they need to continue to grow and be successful. Our kids here in Hustisford deserve the same opportunities that students in much larger schools have. We can provide some of these things for our students but not without additional help from our community.

It is a great day to be a Falcon. We have so much to be proud of. With the continued partnership of school and community working together, we can give our students so much more. We can offer them more opportunities; we can prepare them for the next step in their lives. Our community takes pride in our schools that is something that sets us apart from others. I. Call to order

The meeting was called to order by President Dave Strysick at 6:33 p.m.

II. Roll call of members

Board members signed the attendance roster at the start of the meeting. Members present: Jay Behnke, Dave Strysick, Tracy Malterer, Steve Weinheimer, Lisa Bosse, Barb May, and John Bohonek.

III. <u>Verification of public notice</u>: Heather Cramer, superintendent of schools, verified that the meeting was noticed to the public appropriately as required by S. 19.84 (1), (2), (3), & (4) Wis. Stats.

B. Principals' Reports:

- Ms. Bell Reported: PALS testing is underway in 4 K-2nd grades. Students will be going to the TAG Center in Mayville as an end of semester celebration. The Timber Rattlers will be introducing a reading program to the elementary students. Several staff members will be attending a Non-Violent Crisis Intervention Training. Radtke Appliance in Oconomowoc helped JHE get a new washer and dryer at a significantly reduced cost. Summer School planning is underway.

 Mr. Bushey Reported: Mr. Bushey reported that the district mental health team
- held a meeting. The ACP team also met to plan for the remainder of the year.

 Mrs. Portzky held a career night for 6th graders. The semester ends on January

 18. Student Council will be holding a winter dance on February 17. 92 letters have been sent out to families in regards to truancy issues.

Mr. Kiefer continues to meet with department heads to go over their individual budgets.
- E. **Superintendent's Report**: Mrs. Cramer along with two board members met with a state level FFA officer and talked about the direction that the Hustisford Agriculture Education program would like to take. The compensation committee is gaining momentum and the team is working on building an effective plan for the future of our district. Mrs. Cramer attended several meetings in the area in regards to school issues and athletics. The district provided families with the state report card information. The school calendar should be ready for the board to review in February.

School Board Resolution #1564

RESOLUTION PROVIDING FOR A REFERENDUM ELECTION ON THE QUESTION OF THE APPROVAL OF A RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET TO EXCEED REVENUE LIMIT BY \$200,000 PER YEAR FOR THREE YEARS FOR NON-RECURRING PURPOSES

WHEREAS, the School Board of the Hustisford School District, Dodge County, Wisconsin (the "District"), has heretofore duly adopted a resolution entitled: "Resolution Authorizing the School District Budget to Exceed Revenue Limit by \$200,000 Per Year for Three Years for Non-Recurring Purposes" (the "Revenue Limit Resolution"); and

WHEREAS, the School Board deems it to be desirable and in the best interest of the District to direct the District Clerk to submit the question approved in the Revenue Limit Resolution to the electors for approval or rejection at the regularly scheduled election to be held on April 3, 2018.

NOW, THEREFORE, BE IT RESOLVED by the School Board of the District as follows:

<u>Section 1.</u> Referendum Election <u>Date</u>. The District Clerk is hereby directed to call a referendum election to be held in the District at the regularly scheduled election to be held on April 3, 2018 for the purpose of submitting to the qualified electors of the District the proposition of whether the Revenue Limit Resolution shall be approved.

Section 2. Notice to Electors. The District Clerk is directed to give notice by:

- (a) causing a Notice of Election in substantially the form attached hereto as <u>Exhibit A</u> to be published in the <u>Watertown Daily Times</u> in the issue published the fourth Tuesday before the referendum election.
- (b) causing a Notice of Referendum (which includes the facsimile of the sample ballot) in substantially the form attached hereto as <u>Exhibit B</u> to be published in the <u>Watertown Daily Times</u> in the issue published immediately preceding the referendum election. This Notice shall also be posted in each polling place on election day.

If any of the municipalities within the District use an electronic voting system employing a ballot label and ballot card, the Notice of Referendum set forth in Exhibit B shall also include a true, actual-size copy of the ballot label and ballot card in the form in which they will appear on election day.

<u>Section 3. Polling Places and Hours</u>. The District electors must vote at the referendum election at the times and polling places at which they cast their ballots in regularly scheduled elections.

<u>Section 4. Referendum Election Officials</u>. The election officials appointed in each of the municipalities within the District shall conduct the election.

<u>Section 5. Official Referendum Ballot Form</u>. The ballot to be used at the referendum election shall be prepared in accordance with the provisions of Sections 5.64(2) and 7.08(1)(a), Wisconsin Statutes. The ballot shall be substantially in the form attached hereto as <u>Exhibit C</u>.

The District Clerk shall cause to be printed sufficient ballots for use at said referendum election, both as actual ballots in those polling places which do not use voting machines and as absentee ballots where voting machines are used and as specimen ballots (the latter to be of a different and easily identifiable color from the actual ballot). The form of the ballot shall be filed with the official responsible for providing the ballots for the election, and the District Clerk shall file a copy of the ballot with the clerk of each county having territory within the District, as soon as possible after the date hereof but in no event later than 70 days prior to the election, as provided in Section 8.37, Wisconsin Statutes. If the District prepares the ballots, they should be delivered to the municipal clerks running the election at least 25 days prior to the election, to allow the municipal clerks to comply with their obligation to provide absentee ballots under Section 7.15, Wisconsin Statutes.

The municipal clerks of the municipalities within the District shall receive applications for absentee ballots and initial the same when issued to qualified absentee voters.

Section 6. Canvass. The returns of the referendum election shall be canvassed by the Board of Canvassers of each municipality within the District. Each Board of Canvassers shall certify the returns of the referendum election to the District Clerk. The District Clerk and two other reputable citizens appointed by the District Clerk prior to the date of the referendum election shall act as the District's Board of Canvassers for this referendum election. This Board of Canvassers shall meet in open session no later than 9:00 a.m. on the Tuesday after the election to determine the result of the referendum election. The canvass shall be open to the public and the District Clerk is directed to give due notice of said meeting.

<u>Section 7. DPI Notice</u>. Pursuant to the provisions of Section 121.91(3), Wisconsin Statutes, the District Clerk shall notify the Department of Public Instruction of the date of the referendum election and shall provide the Department with copies of the Revenue Limit Resolution within 10 days after the adoption of the Revenue Limit Resolution and shall further notify the Department of the results of the referendum within 10 days following the election using the method prescribed by the Department. Approved 7-0 Roll Call Vote.

Greetings from Jr./Sr. High School Principal Mr. Clint Bushey



The term Bullying is widely used in today's society and effects a great number of individuals on a daily basis. The definition of Bullying is when an individual or a group of people with more power, repeatedly and inten-

tionally cause hurt or harm to another person or group of people who feel helpless to respond. Here at Hustisford we are working very hard to lessen the effects of these behaviors at school. Research shows the best way to combat these types of behaviors is to increase empathy. We are working to increase empathy in students through our social and emotional learning during Falcon Time activities. This includes Second Step Curriculum, Role Models Curriculum, and Mind Up Curriculum. Additionally staff has included team building activities throughout the school year in their classes. The school has been very fortunate in receiving a grant that enabled us to expose our students to National Renowned speakers in resiliency and bullying prevention. In the fall Kevin Hines spoke to our students about resilience in mental health and the importance of self care. In a couple of weeks Keith Deltano will speak to our students about bullying prevention. For the last two years the staff has been participating in Trauma Sensitive, Non-Violent Crisis Intervention, and Mindfulness Professional Development. The staff and administration have established a Mental Health Framework Team that sets goals for the district in improving aspects of mental health. Recently the district was selected to participate in the National Council for Behavioral Health 2018-2019 Trauma Informed, Resilience-oriented approaches learning community. This is a great honor for any school district. We are currently in year 1 of an 18 month grant cycle for a \$50,000 Mental Health Grant from the Greater Watertown Community Health Foundation. This grant has afforded us the opportunity to provide our students, staff, and community with the tools necessary to really impact mental health needs.

With all of these wonderful additions to our programming we still realize we have a way to go. We feel this is a great start and are committed to doing our best to make this school a safe place for all students. With your help we can continue to grow in this area.

Music in Our Schools

March has been officially designated by the National Association for Music Education (NAfME) for the observance of Music In Our Schools Month (MIOSM®), the time of year when music education becomes the focus of schools across the nation. MIOSM began as a single statewide celebration in 1973, and has grown over the decades to encompass a day, then a week, and then in 1985 to become a month long celebration of school music. The purpose of MIOSM is to raise awareness of the importance of music education for all children – and to remind citizens that school is where all children should have access to music. MIOSM is an opportunity for music teachers to bring their music programs to the attention of the school and the community and to display the benefits school music brings to students of all ages.







11 Facts About Music Education

- 1. Children who study music tend to have larger vocabularies and more advanced reading skills than their peers who do not participate in music lessons.
- 2. Studying music primes the brain to comprehend speech in a noisy background. Children with learning disabilities or dyslexia who tend to lose focus with more noise could benefit greatly from music lessons.
- 3. Research shows that music is to the brain as physical exercise is to the human body. Music tones the brain for auditory fitness and allows it to decipher between tone and pitch.
- 4. Children who study a musical instrument are more likely to excel in all of their studies, work better in teams, have enhanced critical thinking skills, stay in school, and pursue further education.
- 5. In the past, secondary students who participated in a music group at school reported the lowest lifetime and current use of all substances (tobacco, alcohol, and illicit drugs).
- 6. Schools with music programs have an estimated 90.2 percent graduation rate and 93.9 percent attendance rate compared to schools without music education that average 72.9 percent graduation and 84.9 percent attendance.
- 7. Regardless of socioeconomic status or school district, students who participate in high-quality music programs score 22 percent better on English and 20 percent better on Math standardized exams.
- 8. Much like expert technical skills, mastery in arts and humanities is closely correlated to high earnings.
- 9. A study from Columbia University revealed that students who study arts are more cooperative with their teachers and peers, have higher levels self-confidence, and are more equipped to express themselves and their ideas.
- 10. Elementary age children who are involved in music lessons show greater brain development and memory improvement within a year than children who receive no musical training.
- 11. Learning and mastering a musical instrument improves the way the brain breaks down and understands human language, making music students more apt to pick up a second language.
